- Requirement draft status
  - Second round of WGLC ended Aug-30, 2011.
  - Comments incorporated in -05.
  - Publication requested on Sep-09, 2011.
  - AD review on Sep-20, 2011.
    - Minor changes, may result in -06 for IETF LC.



### Administrivia: Mechanism draft

- -02 released Sept-20, 2011.
- -01 released July-11-2011.
- Plan (WAS) to hold WGLC by Sept-15-2011.
  - Still do'able. But ...
- Need more eyeballs looking at -02.
- Agreed dates with AD:
  - Oct-31-2011 Mechanism draft to IESG.
- Therefore, will call for volunteers to review -02 and move work ahead expeditiously.

# Administrivia: ISDN UUI service application usage draft

- One (and only) candidate draft:
  - draft-drage-cuss-sip-uui-isdn-01
- Solicited other drafts on list [1]. No response.
- Therefore, hum for adoption of draft-drage-cuss-sip-uui-isdn-01 towards the third charter deliverable (application specific usage specification).
- Ratify decision on WG list and propose WGLC by Oct-15-2011.
